OBJETIVES

The Master's Degree in Contemporary History is taught jointly by the departments and areas of Contemporary History of eight universities. Its inter-university nature is justified by the need to transcend departmental compartmentalisation in order to offer training of excellence at postgraduate level, which can only be achieved by pooling the resources of the main centres of Spanish contemporaneity.

The objectives of this programme are to create a school of contemporary historians, in which they acquire the knowledge and techniques necessary to be able to undertake research work in History, either as professional historians or in other professional fields such as journalism, museums, cultural animation, teaching, publishing, social and political analysis...

PROSPECTIVE STUDENTS

Students who are admitted to the Master's Degree are graduates (or possibly undergraduates) in History, Geography and History or Philosophy and Letters (in one of the History specialisations), or in any other related official degree, such as Humanities or Social Sciences.

Students with degrees obtained in educational systems outside the European Higher Education Area will need to accredit an equivalent level of training. Students coming from other degrees may be required to complete some complementary training courses. Most of the lectures are given in Spanish.

WHY STUDY THIS MASTER'S DEGREE?

El The Master's Degree in Contemporary History is a consolidated and recognised qualification, a national reference in its speciality. Its academic and research profile offers the possibility of accessing a specialised higher education, oriented towards professional life, and recognised in all the countries of the European Union and in many other states. People who have received scientific training have the best training to work at a high level in a wide variety of professions. Its main objective is to prepare researchers capable of making research their main activity (within the framework of the university, research institutes and centres, in specialised journals...) or complementary (as an extension of their professional activity in archives, libraries, museums, cultural centres, teaching in secondary education...). It also aims to provide ongoing training in the field of contemporary history for different professionals in the field of teaching, information, and scientific dissemination.

STRUCTURE

Este This Master's Degree is structured in two modules and the Master's Thesis:

- Module I: Research Lines: 15 compulsory ECTS (3 subjects of 5 credits each)
- Module II: Topics in Contemporary History: 30 optional ECTS. There are 141 subjects offered in this module, divided into 8 subjects:
 - Subject I: The State and the Public Space: 19 courses
 - Subject II: Identities, Nation and Nationalisms: 12 courses

- Subject III: Rural Societies, Urban Societies: 13 courses
- Subject IV: Cultural History and History of Political Cultures: 29 courses
- Subject V: International, Transnational and Global History: 27 courses
- Subject VI: Social and Economic Changes: 16 courses
- Subject VII: Historiography, Historical Methodologies and Applied Research: 13 courses
- Subject VIII: Violence and Memories: 11 courses
- Master's Thesis: 15 compulsory ECTS
